
Commissioners returned to regular session at 10:18 a.m.

#### Tallgrass and Tumbleweeds by Gaille Pike

Dear Readers,

Five years ago, my first column was about the differences between driving on the East Coast and in Kansas. And I stand by what I wrote in 2020—that the time spent on Kansas Roads is worth it because you get where you're going. You just start your engine and go. By contrast, my automobile excursions up and down the Mid-Atlantic

often simply caused me aggravation beyond description, among other things, and IF I arrived at the destination I set out to reach, I usually had forgotten why I set out in the first place.

I still prefer Kansas driving over East Coast driving. Kansas ranks fifth in the nation for total estimated road miles. I've only covered a fraction of our roadways because I repeatedly take the same routes. For example, I often visit my family by driving nearly straight West. These 252 miles have become so

familiar that the drive goes like clockwork. Including one pitstop, in either direction, this trip is reliably no more than five hours.

But this week, my trek took nine hours. I only got about 11 miles, barely out of Emporia, when my car started shaking like one of those machines at hardware store that mixes paint. And it took me nearly four hours to figure out a way to keep getting down the road.

My regular readers may recall I've had "car trouble" before. In 2023 on K-56 near Marion, an hour from home, my Sonata just up and died. The fleet it took to get me home that day included two Marion deputies, two teams at AAA, a tow truck driver, and a neighbor. To this day, I recommend that all Hyundai and Kia owners call the closest dealership and ask if your make and model are at risk for unexpected engine failure.

Flint Hills Towing was the company that got me and the Sonata to Emporia. And then the next day, they hauled my car on to the dealership in Topeka. My friends

have suggested that they are as much a shipping company as they are a towing company. And in truth, they can get vehicles from one side of the state to another and from top to bottom.

But I did not know until this week that Flint Hills Towing is an authorized Hertz Rental Car. I was desperate when I stumbled on that tidbit of information because the four other Emporia car rental places I'd called first had had no cars available.

Flint Hills Towing did more than just rent me

a car and get me on my way. Once again, I received the most outstanding remarkable service. They helped me move my belonging from the Sonata to my rental AND navigate the AAA system and get my car to my mechanic. Most of all, they kept me laughing when I felt like throwing up my hands, going home and crying.

Until next week-keep your eyes on the stars and your back to the wind.

PS The Sonata's gonna be fine but that's a story for another day



## A Time for Co-ops and Classrooms

"I am so glad that I live in a world where there are Octobers." That beloved line from "Anne of Green Gables" has always captured how I feel about this season. Growing up in Wisconsin, October meant crisp mornings that hinted at winter's approach and warm afternoons that illuminated a canvas of orange, yellow and red across the countryside. It was the month

of cranberry harvests, football games and the simple beauty of smalltown fall.

Now that I call Kansas home, October feels a little different. The fall colors aren't quite as bold, and sweater weather arrives fashionably late. But the season still carries its own charm. Combines hum steadily through fields, tractors plant wheat and grain trucks crisscross the highways. The landscape may look different, but the same spirit of productivity and community fills

In my role as director of communications for our local cooperative, October has taken on additional meaning: it's National Co-op Month. Across the country, co-operatives celebrate this

time by recognizing the strength of the cooperative business model and the values that drive it — member ownership, local leadership and shared success.

One of my favorite ways to mark the month is by visiting agriculture classrooms in high schools across our trade territory. It's an opportunity to talk with students about how cooperatives work and why they play such an important role in rural communities.

During these visits, I lead an activity that illustrates how co-ops differ from other business structures. Students "shop" at various types of businesses — corporations, sole proprietors and cooperatives — and then we discuss where the profits go. The students representing

cooperative members are the only ones who end up with money back in their pockets at the end of the exercise. It's a lighthearted demonstration, but it effectively shows how cooperative members share in both the risk and the reward of their organization's success.

Before our merger last year, I typically visited three or four schools each October. This year, I plan to visit 10. That growth is encouraging on its own, but what's even more remarkable is eight of those schools didn't have agriculture programs when I moved to Kansas 15 years ago.

This expansion of agricultural education reflects the dedication of teachers, administrators and community leaders who understand its

importance. In many of these communities, agriculture isn't just an elective — it's the foundation of local life and livelihoods. These programs provide students with hands-on learning, leadership development and real-world skills that open doors to meaningful careers.

This year, I also joined the Kansas FFA Foundation Board, an organization that has been instrumental in supporting and expanding these programs across the state. Through grants, scholarships and teacher support, the foundation helps ensure that students and educators have the resources they need to thrive. Seeing this momentum firsthand gives me immense optimism for the future of agriculture.

While Kansas may not offer the vibrant autumn palette I remember from Wisconsin, October here holds its own kind of beauty. It's a season of harvest, of education and of community connection. Anne Shirley's words still ring true for me — not because of the changing leaves, but because of what the month represents.

October reminds me to be grateful: for the cooperative spirit that strengthens our rural towns, for the educators shaping the next generation and for the farmers whose hard work sustains us all. I am, indeed, glad to live in a world where there are Octobers.

Blake, "The world of imagination is the world of eternity."

# YEARS AGO IN The Cunningham Clipper

#### 1965

November 4, 1965 - The fifth annual Alumni Banquet of Nashville Rural High School will be held in the high school gym, Saturday evening, Nov. 27, at 6:30 o'clock.

All graduates, teachers, and former teachers are invited to attend.

A dance, featuring the music of the "Midnighters, "will follow the banquet. Banquet tickets are \$2.50 per person, and reservations should be made with Mrs. Lloyd Dicke of Nashville, by November 15.

The first snow of the 1960-1961 winter fell last Sunday, October 30. The snow was very wet and much of it melted as soon as it hit the ground, but estimates place the snowfall at about two inches.

Monday October 31, after school, Cunningham Cub Scout No. 759 distributed over 200 "door bells" for the "Get-Out-the-Vote" campaign to homes in Cunningham.
















#### Cross Country Team Places 2nd in League

Prior to that victory the Wildcats traveled to Inman and Argonia (A&A) and lost both games. In the Inman game Cunningham led 12-6 at halftime, but were outscored by the Teutons 22-12 in the second half, for a final score of 28-18. Touchdowns vs. Inman were scored by Brody Halderson on a 4-yard run and Landon Green scored two touchdowns

on runs of 3 yards and

12 yards. In the A&A game the Wildcats struck first on a 2-yard run by Green that was set up by a pass play from Casyn Miller to Cooper Neufeld. The Titans would answer with a score of their own to tie the game 6-6. The game remained tied until the second half when A&A would score 20 unanswered points and held the Wildcats scoreless to bring the final score to 26-6.

In the Pretty Prairie game scoring was not a problem for the Wildcats as they would score 32 points in each of the first quarters to take a 64-24 halftime lead. Pretty Prairie scored the game's only second half touchdown to bring the final score to 64-32.

Landon Green led the scoring for the Wildcats

with 5 touchdowns, four on runs of 54 yards, 38 yards, 36 yards and 40 yards, his fifth touchdown was a 45-yard picksix. Green also added four of the PAT runs. Brody Halderson scored two touchdowns on runs from 28 yards and 33 yards, he also added two PAT runs. The final touchdown for the Wildcats was scored by Landen Hageman when he intercepted a Bullpup pass and ran it back 45 yards for a picksix touchdown of his own. The Casyn Miller to Cooper Neufeld PAT connection added two more of the scores.

The Wildcats completed their season with a 5-2 record. The team would like to thank all those who supported them during the season.




