Indians Outshoot the Cats at Skyline Tournament

It was raining three point shots by the Medicine Lodge Indians on December 7, 2018 at the Skyline Basketball Tournament. The final result was Cunningham 26, Medicine Lodge 70.

There were many positives that could be taken from this game. Cunningham had five fewer turnovers than previous games, the free throw and field shooting percentages increased, we showed a little more patience in the offense which resulted in better shot selection and as a result we almost doubled our total score from the last game. This is not to say that there is no more room for improvement, because there is.

The Cats scored first on a steal and layup by Daylen Schnittker in the first quarter. Nathan Lohrke added two points for the Cats. Medicine Lodge began their threepoint barrage with three in the first quarter. The score after one was 15 to four in favor of the

Cunningham showed their highest output of the year in one quarter by scoring 13 points in the second quarter. Schnittker and Erik Paris put in five points and Lohrke added a three off the glass. The Indians scored 22 points which included four three-point baskets to lead at halftime 37 to 17.

Cunningham added nine more points in the third quarter with Schnittker putting in five more points. Isaiah Reed made a nice move to the basket for his two points and Paris added two more to his total. The Indians put in 22 more points including four more threepoint baskets. The third quarter ended with a score of 59 to 26.

Cunningham did not score in the fourth quarter and the Indians added to 11 to their total for a final score of 70 to 26.

Taner Hansen led the Cats in rebounding with six. Schnittker finished with 12 points, Paris added 7, Lohrke scored 5 and Reed put in 2 points for the Cats.

Improvement was made, but still more can be done. The Journey continues.

T-Birds Defeat the Cats

December 8, 2018 was a tough night for the Cunningham Wildcats as they were defeated by the Skyline Thunderbirds 73-18 in the Thunderbird Invitational Tournament.

The T-Birds flex their muscles in the first quarter leading 30 to 4 after one quarter. Daylen Schnittker and Taner Hansen each made a basket for the Cats.

Nathan Lohrke and Hansen each put in a three-point basket in the second quarter and Skyline added 19 to end the first half 49 to 10. Skyline scored 16 more points in the third quarter to one point for the Cats. Hansen scored 6 of the 7 Cunningham points in the fourth quarter. Isaiah Reed added a free throw. Skyline put in 8 points for a final score of 73-18.

Our ball handling must get better versus pressure as that is where the majority of our 37 turnovers came from. We also need to do better at the free throw line. The Journey continues.

Wildcats Fall to the Raiders

Cunningham traveled to Argonia on December 11, 2018 to take on the Red Raiders. The team had their best defensive night but are still trying to find that offensive spark. Argonia won by a score of 14 to 44.

Argonia jumped out to an early lead in the first quarter scoring 14 points with Cunningham's Nathan Lohrke scoring on a pull up jumper. The Cats had their most productive quarter in the second scoring 8 points and holding Argonia to 10 points. Lohrke, Daylen Schnittker, Erik Paris and Isaiah Reed each had two points.

Schnittker scored the only basket for Cunningham in the third quarter and Reed scored the lone basket in the fourth quarter. Argonia added 12 and 8 points, respectively in the third and fourth quarters.

On the plus side, this was our first game to not start the fourth quarter with a running clock and we held the Raiders to the lowest point total this season. We still need to improve at the free throw line, shooting 33% on 4 of 12. Most of the misses were front ends of one and ones. We also need to recognize and better defend the other team's best players. Noah Haxton finished with a game high 23 points. More than half of their total. The journey continues.

Early Success Key to Lady Cat

The Cunningham Lady Wildcats had an afternoon tipoff versus an improved and veteran Medicine Lodge team. The Lady Cats came out clicking, finding success of 4 of our first 5 possessions with good execution of scripted set plays. The Indians stayed close with outside shooting that surprised me a bit. After one quarter, Cunningham led 14-8. The middle quarters produced little scoring due in part to sticky defense but also to poor free throw shooting on our part. I seemed like we were 0 for 15 after three quarters when in fact we were 1 for 8, but you get the picture. When he had opportunities to create breathing room, we whiffed. After three quarters, we led 23-18 in a low scoring game. The Medicine Lodge team has much more depth than we do, and they needed it as they committed 28 fouls, many of them down the stretch as they needed to foul us to get the ball back. After a scolding, we were much better at the free throw line when it most counted, connecting on 17 of a whopping 25 fourth quarter free throw attempts. We scored 19 points in the fourth quarter compared to Medicine Lodge's 18 to make the

final score 42-36. We

than 100%, but Jessamy Stalcup played her most significant varsity role and did so in a mostly steady way, a big plus for our basketball team. Lauren Murphy also came up big for us with one of her most complete games while Morgan Meyers was instrumental in managing the final 4 or 5 minutes of the game.

As a team, we shot 35% from the field, which isn't anything to brag about, but at the line, the 68% 4th quarter FT percentage was not enough to offset 1 of 8 through three quarters and our final percentage of 55%

is a poor result. Morgan Meyers with 13 points edged Lauren Murphy with 12 to lead all scorers, but we also got nice support from Holly DeWeese (6 points), Alayna McGuire (5 points), Mackenzie Wright (4 points), and Jessamy Stalcup (1 point). Alayna and Lauren tied in rebounds with 4 each while MacKenzie and Holly tacked on 2 apiece. Holly managed 5 steals with Morgan collecting 4, and in terms of assists, Morgan handed out 4 while Alayna and Mackenzie each added 2.

The final game for us in the round robin tournament will be against host Skyline at 5:00. Skyline has yet to win a game in the tournament but they play hard and are extremely familiar with us, so we will have to come with focus and lots of effort to match theirs.

JH Cats Drop to Stafford



Lady Cats Win T-Bird Classic

In defeating the Skyline Thunderbirds, Cunningham claimed the T-Bird Classic championship for the third consecutive year. In the contest, neither team lit up the scoreboard. In fact, neither team scored in double digits in any one quarter, but at least the Lady Cats won each quarter, even though at times by the slimmest of margins. Our halftime lead of four, 15-11, grew to 9 by the end of the third quarter, and that was a spread we pretty much maintained throughout the remainder of the game, settling in the end with a 28-17 win. A "classic", this game was not.

Neither team cracked the 30% mark on field goal shooting, a sign more of poor shooting than stellar defense. Cunningham shot 29%, just 11 of 38, though four were of the 3-point variety. Skyline was woeful as well, shooing just 7 of 36 which included 0-13 from long range. Trips to the free throw line were few and far between for

both teams, but in our case, perhaps that was a blessing as we made good on only 2 of 6.

The scoring leader on this night was Morgan Meyers with a season high 17. Only three others scored: Lauren Murphy (5), Holly DeWeese (4), and Mackenzie Wright (2). Holly had a big night on the boards, grabbing 9, but Lauren and Morgan made significant contributions with 7 and 5, respectively. Morgan led in steals with 6 while Alayna McGuire snared 4 thefts. Morgan's three assists were just one better than the pair of assists credited to both Mackenzie and Lauren.

Our next opponent is Argonia, an experienced team led by a couple senior players that we will have to account for. In fact, we are diving in to a difficult stretch that reaches in to January during which we will also play, in order, Udall, Macksville, Kinsley, and Attica, ALL good teams that will pose plenty of problems, especially if we don't start shooting the basketball better.

Lady Cats Sloppy in Win

The Lady Cats opened tournament play against Pretty Prairie with a solid defensive effort, but offensively we were very choppy as turnovers often interrupted our intended execution. In the first half of our first outing, we played, for the most part, like a symphony, in sync and with a nice flow. However, our first half performance on this night was more like the 5th grade band and the second half brought little or no change.

Our scoring was consistent, quarter-to-quarter, and in no quarter did we yield more than 8 points. We stacked an 11-2 advantage in the second quarter atop a 12-4 first quarter tally to lead comfortably at halftime, 23-6. Turnovers dominated the halftime talk for good reason - - we committed 16. Pratty Prairie did not take advantage of our miscues because they were too busy emulating us. We finished the game with 25 turnovers compared to the Bulldogs' 26. Translation: not a pretty game. Nevertheless, the outcome on the scoreboard pleases me as we finished with a 47-21 victory.

When we weren't turning the ball over, we were efficient on offense, shooting at a 47% clip from the field (15 of 32). An interesting stat is the comparison in team shooting from behind the arc where we were 3 of 6 while the Bulldogs were

The 1 of 19 (5.3%). charity stripe was not a kind place for us as we shot just 56% on 14 of 25. Our leading scorer was Morgan Meyers with 13 and netting an even dozen was Holly DeWeese. Alayna McGuire provided a healthy scoring punch as well with 9 points. Rounding out the scoring was Lauren Murphy (4), Mackenzie Wright (4), Jessamy Stalcup (3), and Abby Hansen (2).

Maddison Panek was tops in the rebounding category with 5, but her efforts came at a cost as she dislocated a finger on her shooting hand and will miss some action. Lauren had 4 rebounds while Holly and Morgan each contributed 3. Morgan led us in steals with 4 and following close behind was Maddison and Mackenzie with 3 apiece. As for assists, Morgan handed out 7 to lead the way but Alayna was also in the giving mood and ac-

counted for 6 assists. Medicine Lodge is up next for us. They're an improved team over a year ago and rebound well. It will be imperative that we rebound well defensively and that we limit turnovers in order to be in a good position when the fourth quarter rolls around. This game will be Friday, Dec 8th at 3:30.

A longtime resident of El Paso, he was a retired barber.


Jerome was a member of the St. Mark's Catholic Church, El Paso; a lifetime member of the Knights of Columbus; and was a U.S. Navy veteran.
