Motion made by Jason Osner, seconded by Abby Bock, to approve the agenda as presented. Motion carried 6-0.

President Miller welcomed the guests.

Motion made by Jason Osner, sec-

onded by Bjorn Halderson, to approve the minutes of the July 14, 202 regular meeting and retreat meeting. YMotion carried 6-0.





telephone call I picked up the ringing telephone and heard, "Can you help me read better, grandma?" These words from my granddaughter, who recently completed first grade, startled me, but also gave me hope. Hope, because I believed that by wanting help, Lani would work hard. Neither her parents nor I were surprised that she struggled with reading, as Lani arrived in this world three weeks early and spent two weeks in an incubator. Even though her mom and dad read aloud to her several times a day, learning to read re-

mained a challenge. During the summer, Lani came to my house four days a week and when second grade started, Monday through Thursday she rode the bus to my house and stayed for one hour. I read poems to her, we choral read poems and worked on word families. Lani

enjoyed printing words in

the same family on long strips of paper. We hung them on the walls of my office, and Lani chose two to three lists to reread during each lesson. Once her reading of a word list was automatic, she took it home and hung it on her bedroom walls.

For practice and performance, Lani selected a poem each week from a folder I filled with poems by Shel Silverstein, Karla Kuskin, David Harrison, Eve Merriam, and David McCord. As her reading improved, I added longer poems, and she looked forward to performing them for her parents and brother, who celebrated her progress.

Once a week I gathered old favorites and new poems to create a trail of poems that started in the kitchen, continued through the living room, and up the stairs to my office. "Are these for me to read?" she asked. I smiled and nodded. Slowly, we made our way to the office, Lani stopping to read each poem. To this day, she recalls that weekly experience with smiles and pleasure!

Halfway through fourth grade, Lani called me and told me that she was in the next-to-top reading group! "The poems did it!" she said. Yes! Poetry brought Lani into the reading life! Now a high school senior, entering college in the fall to study psychology, poetry continues to be an important part of her life. "Poetry saved me in second and third grades," she said. "I still read poems and have a collection of my favorite poets on my bookshelf: Emily Dickinson, Robert Frost, Mary Oliver, Langston Hughes, Rui Kaur, and Natalie Diaz!" Not only did poetry save Lani, but it continues to be an important part of her adult reading life!

Laura Robb has taught and coached teachers for more than 45 years! She continues to teach and coach, present webinars, and is presently learning with a seventh-grade English teacher. Author of more than 40 books on literacy, Robb received NCTE's Richard Halle Award for excellence in middle school education, Scholastic's Hero Award for outstanding support of teachers, and the Literacy Leader award from Nassau County Reading Council. Her most recent book, co-authored with David L. Harrison and Dr. Timothy Rasinski, is "Promote Reading Gains with Differentiated Instruction" (Shell 2023).

September 8, 1955 – Two hundred and sixty-seven students enrolled in the three Cunningham schools, starting the 1955-1956 school term this week.

One hundred and thirty-nine pupils are attending Cunningham Grade School; ninety-six students are enrolled in Cunningham Rural High School, and thirty-two pupils are attending Sacred Heart Parochial School.

September 8, 1960 – A total of 109 students are enrolled in Cunningham Grade School for the 1960-1961 school year. This is a decrease of 16 from last year's enrollment. The seventh grade boasts the largest individual class enrollment, 21 pupils.

Boys far outnumber the girls 37 to 21, in enrollment figures as Sacred Heart Parochial School began the 1960-1961 term of school last week with 38 pupils, up 13 from last year. The first grade leads all other grades in enrollment with 14 beginners. There are 3 in the second grade, 7 in the third grade, 6 in the fourth grade, 7 in the fifth grade, 7 in the sixth grade, 6 in the seventh grade, and 8 in the eighth grade.

A total of 94 students are enrolled at Cunningham Rural High School for the 1960-1961 school term, down 17 form last years total enrollment.

Seventy-five of the students have Cunningham addresses, with one student from Turon, 11 from Penalosa, three from Nashville, and four from Pratt.

#### Selling Lamb and Agriculture

Glenn Brunkow, Pottawatomie County farmer and rancher

Jennifer and I sell lamb at the farmers market in Manhattan. Yes, it is a great way for us to sell our lamb, but what I enjoy the most is interacting with the consumers who buy our lamb. I take considerable pride in the meat we produce and in sharing it with the end user.

As good as that all is, this is also a chance for me to advocate for agriculture and, in some small way, to help dispel some of the myths about how we produce food. It's not always easy, and I am not always successful, but it is important to

A couple of weeks ago

a gentleman stopped at our booth and expressed interest in purchasing lamb, but first he had a question. He asked if we used pesticides on our farm. I told him we do, and they are a valuable tool in our toolbox.

He then told me he was not interested in buying any meat because it would have pesticide on it. I explained we follow all safety precautions including re-entry and grazing exclusion times. That was not good enough for him, and I could not convince him our meat was free of pesticide residue no matter what evidence I presented to him.

In the end I chalked my interaction up to the old adage of "you can't win them all." However, that does not mean you should not try. In the end we had a very civil discussion, but he would not be swayed by the eviare many other customers who do believe me.

I also had a customer ask me if my meat was free of hormones and antibiotics. I told them, first, that there are no added hormones I could give sheep so that is not a concern. Moreover, I told them that we are in regular contact with our veterinarian and follow the label guidelines on the antibiotics we do give our lambs.

I told the customer we use as few antibiotics as possible, but when my sheep are sick, I want to treat them with the best possible medicine. The health and wellbeing of our sheep is one of the top concerns on our farm. I also said that we are very conscious of proper use of antibiotics because we want them to remain effective for our sheep as well as ourselves.

In this instance I was successful and made ranchers, we need to make sure we take our time and explain to consumers what we do and why we do it. Farmers and ranchers are among the most trusted professionals, and we need to make sure we use this trust to dispel bad information that consumers are constantly bombarded with.

We may not always be successful but that does not mean we should not keep trying to tell our story every chance we get. We're not going to win every conversation, but I believe we can win most of them. Each consumer we do educate is one more friend of agriculture — and we need every friend we can get.






#### Homemade Ranch Dressing - Best on Earth!

"I don't believe in bottled salad dressing... why should you have it bottled? It's so easy to make. And they never use very good oil.'

Julia Child

Ranch dressing is uniquely American. In a 2017 poll to determine our favorite salad dressing (sponsored by the Association for Dressing and Sauces) it received 40% of the vote nationwide (followed by Italian in second place with just

10%). Since 1992 ranch dressing has been the best-selling salad dressing in the United States. Ranch is good stuff. And if you enjoy ranch dressing as much as I do, then this column is for you.

In search of healthy salad dressing options, hoping to avoid unhealthy seed oils, I recently fell down the rabbit hole of online food tutorials. What I discovered is thrilling – healthy homemade ranch dressing that is unbelievably good! This may be the best ranch dressing on planet Earth!

Ranch dressing has an interesting history. In Texas, recipes for buttermilk dressing date back to the 1930s. It is believed that since buttermilk was more available than vegetable oils out on ranches, it became a popular base and ranch dressing was born.

However, a cowboy from Nebraska named Steve Henson is credited with creating ranch dressing in 1949.

While working as a contract plumber in Alaska and cooking for his coworkers, Mr. Henson perfected his buttermilk dressing recipe. In 1954 he and his wife bought a ranch near Santa Barbara, California. They called their new home Hidden Valley Ranch and began serving their buttermilk dressing to guests. Their dressing was so popular they were soon selling it to ranch visitors and local supermarkets. In 1972 the couple sold their name and recipe to Clorox (yes, the bleach people) for \$8 million and retired. Today ranch dressing is popular not only for salads, but it is a favorite for dipping everything from French fries to pizza and more.

As Americans, we love ranch dressing.

For the health conscious, the only problem with commercial ranch dressing is that it is made using harmful seed oils. Ranch dressing that you buy in the store is made with Soybean and/ or Canola oil (both are toxic seed oils linked to cancer, heart disease, and more – do your own research on this). Along with seed oils, store-bought ranch is full of chemical preservatives. The good news is that you can easily and quickly make your own homemade ranch dressing that is free from bad seed oils and harmful preservatives. Your family will love this stuff.

Health concerns aside, perhaps the best reason for making your own homemade ranch dressing is because of the amazing taste difference. Your homemade dressing will taste a hundred times

better than anything you buy. The primary reason for this I believe is simply that you can make it fresh. Like freshly baked bread, fresh roasted coffee, or garden tomatoes fresh out of the sun, fresh tastes better. Your freshly made dressing will delight and amaze your family and friends. Here is the recipe that I have been using. Note you can add to or alter this recipe in any way. Consider this a basic reci-

Ingredients needed: \*1 cup mayonnaise (I use mayo made with avocado oil – Primal Kitchen brand is best tasting and has no bad seed oils regular mayo is made with soybean or canola oil – read labels).

pe and adjust as you like.

\*1/2 cup buttermilk (amount may vary - add this last and make dressing as thick or thin as you like).

\*1/2 cup sour cream

(I like the Daisy brand – pure and natural with no additives).

\*2 tsp. lemon juice (fresh)

> \*2 tsp. dried parsley \*1 tsp. dried chives

\*1 tsp. dried dill

\*1/2 tsp. garlic powder

\*1/2 tsp. onion powder

\*1/2 tsp. sea salt

\*1/4 tsp. black pepper

\* optional Worcestershire sauce

(few dashes - try with/without)






#### Etta Mae Frampton




