As I watch my chickens meander about the place as if they own it (and in their little minds they do) I am fascinated by the fact that they are a direct and living descendent of the dinosaur. With their scaly legs and hollow bones they are generally accepted as the closest living thing we have to theropods. That would be T. Rex. Thank goodness chickens were domesticated about 8,000 years ago. Otherwise we'd be running in panic as they swoop down from the trees and attack us from above like little clucking pterodactyls. In this day and age when it comes to chickens we are the predators, harvesting them for meat and eggs. But we are also their protectors, so much so many people keep them as pets.

And chickens do make great pets. They like to sit in your lap and be petted. They cackle and coo and cock their heads and there are folks out there who have categorized their vocalizations to the point where you can almost tell what they are thinking and feeling. ### My Breast Cancer Experience: Part 35

By Beth Blasi 2025 Fall 2025 – In my last update, I was lamenting how dry it was and the little rain we received around Easter. Then recently, we had all been lamenting about how wet it has been. We hate to complain, and remain thankful for the rain, but wheat harvest was tough to finish and now trying to get wheat planted, corn harvested, and hay baled is the next challenge with all the muddy fields. We've had some dry days (notice I say "Days") and everyone is very busy. Hopefully the waiting time was enough for the army worms to feast on the volunteer wheat and move on.

And mowing the lawn!

Usually by now, we have put the lawn mower away or might have one final round kicking up dust. However, it has been a weekly job, when you could squeeze it in between the rain and waiting for the morning dew to dry. The grasshoppers still ate things they shouldn't even with all the green stuff around. Was it my imagination that they were fatter than

Surprisingly, bloodwork was not required to determine if I should continue the estrogen blocker pill. I guess it's a relatively new test called a Breast Cancer Index Panel (BCI). It uses some of the original tumor tissue to look at the activity of 11 genes to determine if continuation of the hormonal therapy is beneficial. Remember, at the start, there was an ONCO score to help determine whether chemotherapy would be beneficial. I also had a genetic test to determine that I did not have the BRCA gene. Not sure if they now do the ONCO and BCI testing at the same time or wait? A big wonder is thinking about the fact that the original tissue has been preserved somewhere! In reading the pathology from that time, it seems they sliced and diced the tissues and preserved it? And where is this huge warehouse that preserves all these tissue samples? It is truly amazing how all this works. The Doc says they keep the tissue for 10 years. Alas, my results indicated I would benefit by continuing to take my estrogen-blocker

for another 5 years. Even though it appears the risk of cancer returning is a low percentage (about 5.6%), continuing the pill reduces that to around 2%. The Doc says that if the cancer returns, it returns with a vengeance and is very nasty. So, even though I was hoping to discontinue at least one pill, I will continue. I don't seem to have any huge, noticeable side effects from the estrogen blocker so I continue - sigh.

Earlier this year, one of my lower molars delash out when threatened cided I was getting old. This tooth had a root canal and crown but the remaining tooth underneath decided to deteriorate. At first, I thought I had a large canker sore on my gum but eventually discovered it was actually a pus pocket. So, the tooth had to come out. I hadn't had a tooth extracted since having my wisdom teeth out years ago. You can actually hear a cracking sound as the dentist is standing up and pulling the tooth out. Thankfully, it all came out in one piece. The next decision was: Just leave a blank space where the tooth was, put in a bridge (which effects two other teeth), or do an implant - the last two options having a cost to them, of course. Since there was a lonely tooth at the back of my mouth (on which

graft inserted, and a re-

turn visit to check on the healing and a full mouth x-ray. 3 months later, the screw was screwed into the bone (literally the dentist was standing up and using a small wrench to screw it in!). Another 10 days, then another 3 months to check on the healing. Of course, as my luck goes, the "healing cap" that is screwed into the implant cone, fell out as I was eating Raisin Bran one morning while on a short vacation (so glad I didn't swallow it!). So, another trip to the dentist to get that put back in. All they had to do was just screw it back in and, of course, another x-ray. However, after that, another week and they scanned the area for the tooth and another week and finally, finally, the fake tooth was finally locked in place after 9 months. What a process is a crown – said crown (and the dollars)! But, I then pulled off with the help of a Milk Dud), I am so glad to be able to fully chew things on that decided to try the implant as a test run for future side again! tooth issues. ### Ode to the ordinary

In a world awash in tragedy, it's easy to overlook the ordinary: the simple beauty of the everyday, the breeze that reminds us to inhale and exhale, the still moments that whisper, "Look. See. Live." Yes, poetry allows us to grapple with hard questions, but it also leaves room for daily gratitude.

Slow down. Breathe. Note three miracles about the body. Look in front, in back, and to each side of where you are standing. Acknowledge any change in perspective. Embrace surprise.

In your backyard or at a park, observe one creature, one motion, and one color that bring you joy. Walk to a different location and repeat. Talk with a stranger about what you discovered.

Before you write anything, revel in something ordinary, something that — like most of us — you may very well take for granted: the way shadows angle across the floorboards; how baked bread reminds you of your great aunt; or why a firefly, suddenly appearing out of the dark, brings the light you needed.

This, too, is the stuff of poetry: the ritual of laundry, the aroma of rain, the whir of a fan, the taste of brussels sprouts. Years ago, as a student editor of The Louisville Review, I read a poem entitled something like "To the Chicken I'm Cooking." Though I don't recall the author, I remember well the sense of freedom that even a chicken (even the chicken that I'm cooking right now in my real and ordinary kitchen) can, indeed, be the stuff — or stuffing — of poetry. It's good to be reminded: We write to discover what we don't know; we also write to discover more about what's been right in front of us all along.

The everyday is where we live. Find something in it to praise.

### **Praise Poem for the Ordinary**

For the pebble, the worm, the clothesline, the warm bread, the simple turn of head that says, "I heard you," the burr that lets go on its own, the bluebird that returns to perch where the dogwood's blossoms glow, the dim light outside, the bright light within, the low hum of hope when the unseen grows deep in the hole you've dug in dry dirt on an ordinary afternoon just this side of Eden's repeated hallelujahs.



### Wheat Scoop: October is National Co-op Month

Whether stopping by for a quick chat and a cup of coffee or picking up fertilizer for planting, local elevators are a hub of activity and advice for farmers, especially during the busy fall season. Each October since the 1930s, the American agriculture industry has shown appreciation for these member-owned, member-controlled businesses during National Co-Op Month.

The 2025 theme, "Cooperatives Build a Better World," highlights how agricultural cooperatives continue to evolve to meet the needs of their farmer member-owners. Just as Kansas farmers adopt new technologies and management practices, agricultural cooperatives invest in infrastructure, leadership programs and services to help their members succeed.

"Local farmer-owners of Kansas cooperatives are the backbone of the Wheat State," said Russell Plaschka, president and CEO of the Kansas Cooperative Council, the organization that has represented the cooperative business model in the Sunflower State since 1944. "When we talk about a circular economy, cooperatives exemplify this through the cooperative principle of concern for community. The majority of the dollars generated from wheat and other commodities typically stay local, supporting local economies and helping sustain our rural communities into the future."

Cooperative Council represents cooperatives across all sectors, including agriculture, finance, utilities, housing and more. The organization provides education, advocacy and public outreach to promote the cooperative business model and strengthen the network of member-owned organizations throughout Kansas.

Cooperatives play a vital role in Kansas communities, employing more than 5,000 people across 575 locations statewide and serving more than 100,000 members. Kansas is also home to three of the nation's top 100 agricultural cooperatives, showing the state's deep roots in collaboration and shared success.

By definition, a cooperative works for the mutual benefit of its members, who own and control the business. Nationally, nearly one in three Americans are member-owners of a cooperative of some type, according to the National Council of Farmer Cooperatives. Agricultural cooperatives enable producers to pool resources and expertise to strengthen their operations while returning earnings, known as patronage, to members.

October is generally jam-packed for my family, and this year is no exception. Attending my son's football games, finishing up our calving season, celebrating birthdays, continuing fall harvest and preparing to sow wheat have taken up the majority of my family's attention and effort this month.

My mother-in-law, the kids and I added to our October schedule by recently participating in a market of farms popup event organized by Shop Kansas Farms and Kansas Farm Bureau. Producers from across Kansas brought their products to the pop-up market to increase visibility, connect with customers and ultimately sell

their goods.

My family, minus my father-in-law and husband who stayed home to keep harvesting, took our popcorn and popcorn popper to the event and had a fantastic day of handing out samples, having great conversations and sending customers home with our product.

A number of people I visited with at the market have since connected with me through social media or email.

Many of these messages have centered around October being Farm to School Month and how many Kansas schools participate with other states within the region in an annual Crunch Off competition.

The goal of the October Crunch Off is to see how many students, staff and community members can crunch an ag product from their state as a way to highlight locally grown items.

Since many schools have their own popcorn poppers, and popcorn makes a great crunchable snack, we've sent bags of our Kansas-grown popcorn to schools all across our state for these events.

While there's still plenty of October remaining, it's been quite rewarding to connect with schools, see pictures from their social media of their students crunching our popcorn and even discussing opportunities to incorporate our little popping crop in their school concessions or cafeterias to use well beyond Farm to School Month.

As Kansas farmers, we know the wheat, sorghum, corn and soybeans we harvest annually on our farm help feed and fuel the world — even though we don't know

exactly who uses the grain once we deliver to the elevator. Our popcorn crop, on the other hand, has allowed us a personalized window into the lives, homes and communities of those we are helping feed. It's allowed us the opportunity to connect with consumers, to share our story and to serve as a resource.

It's become increasingly clear to me that more and more people want to know about their food and the people who grow it. Events like the pop-up market and school Crunch Offs are examples of ways to create connections between family farms and consumers while highlighting the great products being produced within our state.




