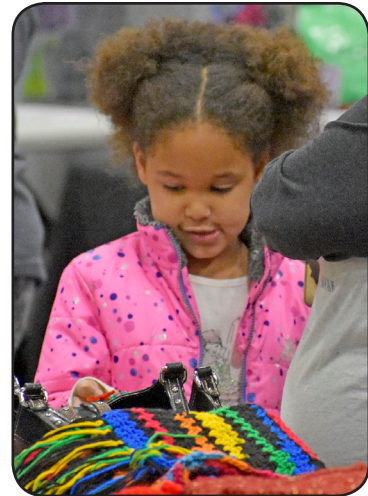

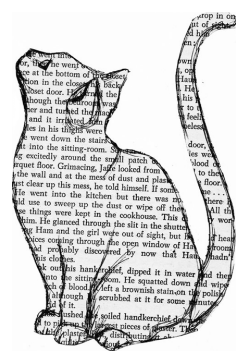

Meanderings

Oh, rats! Rats! Rats! Rats!

In last week's column I mentioned an illustration in a book of collected stories by Edgar Allan Poe: There was that guy tied to a table with rats (shudder) crawling all over him and the pendulum hanging above. “They swarmed up me in ever accumulating heaps” was the caption.

I don't particularly care for stories where the animals talk, and thus, I can't think of many "rat" characters in stories that I like. There is Nicodemus and his troupe of escaped rats in "Mrs. Frisby and the Rats of NIHM" by Robert C O'Brien. I did like that award-winning book a great deal.

I guess I liked "Ratty" from "Wind in the Willows" by Kenneth Grahame. I don't dislike him.

Then there is Chiaroscuro (known as "Roscuero") in "Tale of Despereaux" by Kate DiCamillo. He was a good rat.

I have a book on my shelf titled "I was a Rat" by Philip Pullman that I am going to try and read this week.

One of my favorite authors, Avi, has written a story "Christmas Rat" I'd like to read...someday. Either in this lifetime or the next.

We often use 'rats' as a mild expletive. I did a bit of research and one website (hammertechltd.com) gave this as three reasons, but I think this is the best one: ‘Drat’ was first used early in the 19th century. It was a shortening of ‘od rat’ which was a euphemism meaning God rot. Drat has been adapted to rats. This definition comes from the new Oxford American dictionary.

THEN I thought of two stories about rats.

The summer of 1983 I ventured to the Flint Hills for a summer job as a camp counselor at Wiedemann Girl Scout Camp. It was rather primitive in those days. We slept in tents draped over wooden framed platforms. There was a screen door at the front to exit when the flaps were down. There was a creek that ran through the camp, and some of the units were within yards of it. They had several little bridges one could walk over to cross that little meandering creek.

One of the camp “legends” the girls told was about a rat that crawled along one of the boards during the night and bit a camper as she was sleeping. She had to have rabies shots and lots of other shots and she almost died.... And... and...

My fellow counselors and I'd been there for a few weeks when we were told there was stormy weather headed

our way. Before going to bed, we “battened down the hatches”. All tents flaps were tied to the platforms, screen doors were secured.

I woke in the night unable to breathe. (I'd had asthma when I was younger, and although I'd mostly gotten over it, I could still get quite wheezy if conditions were right) The wind was howling, and the rain was pelting the tent. I sat up, hoping to catch my breath, but there was no air circulating and it must have been over 100 degrees in that tent. I pulled the tent out a bit from the floor beside my cot, thinking I could get some air that way. When I looked down at the ground underneath, I saw that little creek was running under out tent. We'd gotten a lot of rain. I saw limbs and leaves rushing by in the turmoil, but I still couldn't get any air.

I got up, stumbled to the door, opened it, and there was a big rat huddled against it. Oh! UGH! It didn't help my breathing any. I woke one of my tent mates. “Rachel?” I shook her shoulder until she opened her eyes. “I'm having trouble breathing. I need to open the door.”

“Okay,” she said, “can I do anything?”

“There's a rat outside the door.”

“OH! #\$%%!” She flew out of bed, knocking backward onto mine. “I hate rats!”

She turned on a flashlight, and lighted the door. There was about 12 inches of tail sticking under the door. Rachel is scrambling around. “Oh! What can we use? We have to get rid of that thing! Here!” She picked up a gallon-sized bottle of Clorox and thumped it down on the tail. It disappeared. She very carefully opened the door. No rat. I stood out on the little landing, getting soaked, but I was finally able to breathe. Rachel joined me and watched the creek rushing by. Swirling and whooshing.

I felt a little bit bad about making the creature “jump ship.” But they are survivors and I hate rats.

Well, now I'm out of room, the next story will be next week.

Rat stories. What an interesting choice for the Christmas holidays.

Defense Sets Tone In Lady Wildcat Victory

On a night when we weren't too clean on offense, we got dirty on defense and smothered the Lady Indians from Medicine Lodge. The Lady Indians scored 54 points in their opening round win and made it clear who their number one offensive option was. We worked hard to deny entry passes to her, and effectively disrupted their offense with a combination of defenses to clear a path to victory. Early turnovers - three in the first two minutes - got my ire, but we didn't allow points off of those turnovers and pushed out to a 14-2 lead. We had the edge in the second quarter as well to lead

at halftime 26-10. While our half court offense was just soso, we did get a number of points in transition which helped. I believe the early part of the third quarter is one of the most critical junctures in most games because teams make adjustments at halftime and dealing with such can impact the direction of the game. When we nearly pitched a third quarter shutout while scoring 16, the game was settled. The final score of 47-19 may raise some eyebrows because Medicine Lodge is a pretty good team as I think their season results will begin to prove, but it's encouraging to me to have these results on a night when we were not at our best. We definitely need to focus on rebounding as the Lady Indians got the best of us in this department, 36-29.

We shot 38% from the floor, the poorest results in this young season, but finally at the free throw line we exceeded 60% on 11 of 18 (61%). Further evidence that we weren't clicking offensively is revealed in the 0.89 points per possession, something I like to see at 1.00 or above. However, I really liked the balance among our scorers as 7 contributed, led by Morgan Meyers' 16 while Madie McGuire added 9 points and Mackenzie Wright 8. Rounding out the scoring was Holly Deweese with 6, Maddi Panek with 4, and Alayna McGuire and Reese McGuire accounting for 2 points apiece.

Madie led our team in rebounds with 7,

but Holly, Morgan, and Maddi followed closely behind with 6, 5, and 4, respectively. Morgan set the pace in steals with 6 while Alayna and Holly each had 3. Morgan had 6 of the team's 10 assists and Alayna had 2.

The final game of this tournament is against host Skyline, and they seem to get up for us, so we will need to come ready to play. Our defensive effort has earned an A+ from me thus far, and I'm not an easy grader. I know the opponent's score means something to these girls so I expect more of the same.

Celebrations of Life

Earl Gatz

Earl E. Gatz, 89, passed away on November 28, 2019. A funeral service will be at St Paul’s United Methodist Church, 7740 Lackman Rd, Lenexa KS 66217 on Thursday, December 12, 2019 at 10 am. The family will travel to Pratt, Kansas after the service and a brief reception for family and friends.



Earl was born at home in Preston, Kansas on July 17, 1930 to Dr and Mrs Isaac F. (Ike) and Dorothy (Ellis) Gatz. He was the youngest of three children; an older brother, Jack, and a sister, Kathy.

Earl’s parents lived and worked on the family farm near Preston where Ike also ran a veterinary practice. Ike was in the Kansas State veterinary graduating class of 1922 followed by Earl in 1956 and Earl’s son, David, in 1984. Dorothy also attended Kansas University.

Earl met and married Nancy D. (Murray) in Manhattan, Kansas in 1954 where they both attended college. Nancy and Earl were married for 65 years.

After college, Earl served in the US Army at the Presidio in San Francisco, California. Nancy has fond memories of the two of them and their newborn, Janet, living at the Presidio overlooking the Golden Gate Bridge.

While at the Presidio their ‘Army’ baby, David, was born. Later they moved to Iowa where Earl worked for a veterinarian, and following his father’s stroke, Earl moved back to Kansas with his young family. Another daughter, Karen, was born in Pratt, Kansas soon after their arrival. Two more daughters followed, Suzanne and Kathleen (Katie), also born in Pratt.

Janet lives in Stilwell, near Kansas City; David in Amarillo, Texas; Karen in Piedmont, California; Suzanne in Ballarat, Australia; and Katie in St Louis, Missouri.

After arriving in Pratt, Earl set up his own veterinary practice, the Town and Country Veterinary Clinic, that operated for almost 50 years. Many around Pratt knew Earl as ‘Doc Gatz’ and he was well known in the district. Nancy helped in the clinic, looked af-ter a large and busy family and taught in the local schools.

Some of the family’s favorite memories are of their father enjoying his evenings and weekends on the golf course with his friends. After the demanding years of working and providing, these were times of simple relaxation and the company of good friends and lots of laughs. Earl possessed a sense of fun and humor that truly shined in the company of these dear friends.

As the children grew, Earl and Nancy had many opportunities to visit them at their homes and favorite vacation spots including San Francisco, Cape Cod, Florida, Texas, New Zealand and Australia. They also traveled in Europe visiting or accompanying their children.

Earl was Veterinarian of the Year in 1984 and served 17 years on the Kansas State Board of Veterinary Examiners. He was a lifelong member of the Kansas Veterinary Medical Association. He also served eight years as a Trustee of the Pratt Community College and was a member of the Pratt Presbyterian Church, a church founded by his maternal grandfather, Rev. Andrew Axline in 1884. Earl retired and moved with Nancy to Olathe Kansas 12 years ago.

Earl is survived by his wife, Nancy and five children - Janet, David, Karen, Suzanne and Katie; 13 grandchildren and several nieces and nephews.
